# Texas Bar Foundation to receive \$4.2 Million Cy Pres Award

A \$4,255,915.56 cy pres award to the Texas Bar Foundation was approved by Chief District Judge David C. Godbey of the U.S. District Court for the Northern District of Texas from the \$11 million settlement in Heath, et al vs. Insurance Technologies Corp.

The Texas Bar Foundation would like to thank John Yanchunis, attorney at Morgan & Morgan, who served as co-lead Counsel in the case, and coordinated the award.

The other co-lead counsel in the class action litigation was Joe Kendall of the Dallas firm Kendall Law Group. The class was additionally represented by Gary M. Klinger, Gary E. Mason and David K. Lietz of Mason Lietz & Klinger LLP in Washington D.C., and M. Anderson Berry of Clayeo C. Arnold in Sacramento, California. Insurance Technologies was represented by Dallas attorney Peter L. Loh of Foley Gardere and San Francisco, California attorney Eileen R. Ridley of Foley & Lardner.

This cy pres award will help the Texas Bar Foundation to fund projects that will enhance the rule of law and system of justice in Texas, benefiting our entire community well into the future.

For those involved in a class action case, consider designating the Texas Bar Foundation as a cy pres recipient when complete dispersal of the award or settlement is not practicable.

Last year, the Texas Bar Foundation funded \$1,529,051 to 100 organizations across Texas. Recent grant recipients include:

ChildSafe (San Antonio) \$15,000

Foreign Language and Sign Language Interpreters for Victim Services

To provide victims of child abuse certified, trauma-informed language and sign language interpreters as necessary for forensic interviews, family support, and therapeutic services.

# Education Based Housing (Houston) \$9,000

**Building Community Advocates & Legal Clinic** 

To connect lawyers to vulnerable populations in Houston and equip low-income people to become self-advocates and leaders in their communities.

Lone Star CASA (Rockwall) \$22,315

Innovative In-Home Child Advocacy in Response to New Legislation

To recruit, train & supervise advocates to offer in-home supportive interventions to families who are being investigated by CPS but whose children remain at home.

# Lone Star Justice Alliance (Statewide) \$37,500

Juvenile Sentencing Project/Survivor's Project

To provide free legal services to survivors of human trafficking & domestic violence seeking clemency for crimes tied to their victimization & child victims of trafficking in Texas Juvenile Justice Detention.

# **Texas Young Lawyers Association** (Statewide) \$48,000

Adulting

To create a multimedia website that educates students and the general public about their rights and responsibilities under the law upon reaching adulthood.

### Voz de Ninos (Laredo) \$18,000

Expansion of Advocacy Services for Vulnerable Children in the Foster Care System

To provide an additional Advocate Supervisor to serve more abused and neglected children in Webb County.
